## **NATIONAL NENA** (Ron Bloom)

With all positions being uncontested, there will be no election for 2016 officers and everyone will be sworn in at the November Conference.

**OLD BUSINESS:**

**Advisory Board Report-(Jana Fear)-** Glenna Johnson advised that all the submitted names for the Advisory board have been tentatively approved and they should start to receive their acceptance letters, once that is done the Advisory Board will have a meeting.

**Legislation/Advisory Board:** (David Tuttle and Ralph Caldwell) - Steve Rauter provided a power point, which has been placed on the ILNENA website, covering the most current legislative changes for 911. Steve advised that you must submit your consolidation plan by 07/01/2016. Past systems grant requests will be considered last, new consolidation grants will be paid out first. This is the 8<sup>th</sup> year 911 funds have been swept and the state of IL is considered “unstable” and is ineligible for any Federal Grants. There is \$150,000,000.00 available for grants for NG but IL is ineligible. The CAMA Trunk and Toll costs will now be paid by the state with the new legislation and we should see this change on our bills in January 2016. Steve advised that your wireline count that your wireline funds will be derived from will be your 2013 numbers. Steve advised watching SB2032 which includes funding for 911.
